ROLL CALL – Present at the meeting, Mayor Steve Odenborg, Council Members Nyla Roach, Deputy City Clerk/Treasurer Debi Zenner. VIA ZOOM: Council Member John Hermann, Bill Krick and Cody Bailey, and City Attorney Jennifer Douglass

Motion made by John, seconded by Nyla, to go into executive session under Idaho code 74-206 (1)(f) and 74-206 (1)(a);

ROLL CALL VOTE: Roach, Krick, Bailey, Hermann; AYES, motion carried.


- A. **Idaho Code Section 74-206 (1)(f) Pending Litigation:** *To communicate with legal counsel for the public agency to discuss the legal ramifications of and legal options for pending litigation, or controversies not yet being litigated but imminently likely to be litigated. The mere presence of legal counsel at an executive session does not satisfy this requirement*
- B. **Idaho Code Section 74-206 (1)(f) Pending Litigation:** *To communicate with legal counsel for the public agency to discuss the legal ramifications of and legal options for pending litigation, or controversies not yet being litigated but imminently likely to be litigated. The mere presence of legal counsel at an executive session does not satisfy this requirement; AND 74-206 (1)(a) Personnel:* *To consider hiring a public officer, employee, staff member or individual agent, wherein the respective qualities of individuals are to be evaluated in order to fill a particular vacancy or need*


