**CALL TO ORDER** - The Genesee City Council met May 2, 2023; Mayor, John Hermann called the meeting to order at 6:00pm.

**CONSENT AGENDA:** Bill made a motion, seconded by Nyla to approve the consent Agenda as presented, along with payment of the bills. **ROLL CALL VOTE: Krick, Roach, Aherin, Bailey; AYES motion carries.** 

#### UNFINISHED BUSINESS:

**RV PARK OPERATIONAL RULES AND HOST AGREEMENT:** Nyla asked the RV Park Host Agreement and RV Park rules be added to the Council packets. Cody thought we might have a Resolution with months of operation, costs per night and how

ny consecutive nights someone could stay. Discussion regarding the necessity of having a camp host. Cody and Nyla coreed, a camp host isn't necessary. Cody thought we might consider something in writing, as guidance, for future Councils.

#### **NEW BUSINESS:**

**YARD WASTE DISPOSAL PROPOSAL-** Jeff Williams made the comment our yard waste dumpsters always seem to be full. Dustin said we are on a Monday, Wednesday, Friday cycle for emptying. When the season is slower, we are on an on-call basis. The city is charged \$145 when the containers are changed out. Jeff Williams has shown an interest in the City's yard waste disposal, and feels most everything can be reused. Branches can be chipped and reused in compost mulch, groundcover, etc. Grass clippings can also be used as mulch and other things. Jeff feels in the future, our yard waste could support itself or cost very little. Ideally he would need 2-3 acres for composting, a chipper and a dump trailer. We will have a lot of space at the old waste water property, if we decide we want to get started with this. Jeff would be willing to work with the City to get started. Mayor Hermann would be interested in a more detailed plan to manage and have a dollar amount put on it. We might also want to have Scott Becker look into grants for this.

Even though Western was the lowest bid, the contract still hasn't been awarded.
