**CALL TO ORDER** - The Genesee City Council met October 17, 2023. Mayor, John Hermann called the meeting to order at 6:00pm.

## UNFINISHED BUSINESS:

**Water Project Update—Ryan Rehder: Wastewater Update:** Terrence gave handouts and updated the progress of the wastewater project. Hoping to have all the earthwork done by the end of the week and to get the lagoons lined also this fall, weather permitting. They are going to begin on Cow Creek tomorrow. Project submittals have been going through the review process. Avista is still working to get power to the site; said the increase in Davis-Bacon wages in both Latah and Nez Perce counties were missed during the last bid, but it shouldn't have much of an impact in the overall cost. We will have a monthly progress meeting, at City Hall, the second Tuesday of the month, beginning November 14<sup>th</sup>. **WATER:** Looking at the upper park, below the school and the East reservoir for Well #9. Will submit those locations for approval. The park at the school would be a noise issue, with the school and homes on three sides. Power is the issue at the East Reservoir site.

Motion made by Jesse, seconded by Nyla, to come out of Executive Session and back into Regular Session; **ROLL CALL VOTE: Bailey, Aherin, Krick, Roach; Ayes, motion carries.**

Motion made by Cody, seconded by Bill, to go into Executive Session under Idaho Code; Idaho Code 74-206 (1)(f) To communicate with legal counsel for the public agency to discuss the legal ramifications of and legal options for pending litigation, or controversies not yet being litigated but imminently likely to be litigated. The mere presence of legal counsel at an executive session does not satisfy this requirement; **ROLL CALL VOTE: Bailey, Aherin, Krick, Roach; Ayes, motion carries.**

Motion made by Cody seconded by Bill to come out of Executive Session and back into Regular Session; **ROLL CALL VOTE: Bailey, Aherin, Krick, Roach; Ayes, motion carries.**


