## **NEW BUSINESS:**

**IRWA Open Board Position-Dustin -**Dustin was approached by a retiring board member if he would be interested in running for his seat. ## CITY OFFICIAL, COUNCIL AND STAFF REPORTS

Mayor Update: CEDA information was distributed to council for any interested members to attend. Jay, from B&I Computer is getting closer to the M365 migration. Mayor Hermann asked everyone to bring their IPads back to City Hall. At some point, in the near future, we will advertise and sell them, via sealed bid, as surplus. Mayor Hermann also informed Council a check for AVISTA was printed for power on the new wastewater project for \$75K. Council will be kept informed on the pay requests that happen between council meetings. John and Dustin will review all pay applications. Cody asked if council could get an email update on the construction meetings. Jesse wanted to remind everyone there were specific steps to follow when we make payments, so we want to make sure we are following the correct procedures.

Bill Krick – Water and Sewer Update: Bill spoke about the construction meeting held today between representatives from the city, Mountain Waterworks, and Western Construction. They discussed tile lines and moving tons of dirt.

WATER: Well #9: lower park was evaluated by DEQ and it had trace amounts of PERC, a forever dry cleaning chemical. They are now looking at the park below the school. There are a lot of specific restraints they are checking on.

Cody Bailey - Street Update: Child pedestrian safety grant bid opens on the 19th

Jesse Aherin - Administrative Update: No update

Nyla Roach - Parks Update: No update

**CORRESPONDENCE:** Letter from Civic Association President, Rick Schellenger: Council wanted to thank Civic for offering to purchase new chairs for the Senior Center. New racks for the chairs will be built with purchased materials, by Civic. Mayor Hermann suggested we look into the City buying these, since we are tax exempt and Civic could reimburse. Mayor Hermann gave Rick permission to proceed with this purchase.
