Cody asked if Scotts retainer fee was always covered by streets, Dustin states he made the decision because the only thing Scott has reviewed is the chip seal project but normally the retainer fee would be spread throughout the departments. Jessica wanted to confirm \$5000 for tree trimming was correct. Dustin confirmed that was correct and stated the work was done on the trees in the upper park. Cody also wanted to confirm that the bill for the sidewalk replacement was going to be reimbursed by the business owners and that streets still had room in the budget to complete the planned projects. Dustin confirmed that was really the only mechanism he had in the budget with potential sidewalk projects and an income side on grants. Dustin did inform council that there was about \$9000 that would come out of the city budget for the east side of City Hall, a small part in the city park, and an upgrade on replacing the curb due to the condition. Bill wanted to confirm for sewer and capital outlay that's going to be part of the project for underdrain samples and the generator fence. Dustin confirmed this would be reimbursed by DEQ and invoices would be submitted the next pay app and the income will come back in. **Motion made by Jesse to approve the consent agenda as presented; seconded by Bill.
